The privacy protection of the users of the WygodnaDieta.pl portal is of great importance to us. That is why we have developed this document, which presents our position on the collection, processing and use of information about users. WygodnaDieta.pl reserves the right to make changes to the Privacy Policy. Protecting the confidentiality of our clients' personal information is of utmost importance to us.

### 1. Personal data

The Administrator informs Users that he entrusts the processing of personal data to the following entities:

- Edrone Sp. z o.o., ul. Lekarska 1, 31-203 Kraków, NIP: 676-248-20-64, KRS: 0000537197: – for marketing purposes only and exclusively for the purposes of email, SMS and social media campaigns launched or indicated by the Administrator using the edrone system.

All personal data we process has been obtained from you through your contact with us via at least one of the following channels: telephone contact; electronic contact via e-mail; messages on our social media channels; edrone tracking codes; using the contact form available on the website [www.wygodnadieta.pl/zamowienie](http://www.wygodnadieta.pl/zamowienie) or *"Masz pytania? Zostaw numer - oddzwonimy"*; personal contact with a dietitian / consultant at the WygodnaDieta.pl office.

We process your personal data because it is necessary to conclude and perform the contract concluded with you. In addition, the law requires us to process your data for tax and accounting purposes. We also process your data on the basis of a legitimate interest (eg for the purpose of direct marketing of own services, providing services for payment transactions, debt collection, conducting court, arbitration and mediation proceedings, for statistical purposes, ensuring accountability).

If you agree, we process your personal information for the purpose:

- saving data in cookies, collecting data from websites and mobile applications, in accordance with the privacy policy Wygodnadieta.pl;

- providing commercial information about products and services of WygodnaDieta.pl to the e-mail address you specify.
- edrone tracking codes - in order to analyze the statistics of the Store's website, as well as for marketing purposes only for the needs of e-mail, SMS and social media campaigns launched or indicated by the Administrator using the edrone system.

Providing personal data is voluntary, but it is necessary to conclude and perform the contract concluded with you and is therefore necessary for the execution of your order. These are the following personal data: name and surname, e-mail address, telephone number, delivery address.

If for some reason you do not provide this personal data, unfortunately we will not be able to conclude an agreement with you, and as a consequence you will not be able to use the services of Wygodnadieta.pl.

If required by law, we may require you to provide other data necessary eg for accounting or tax reasons. In addition to these cases, providing your data is voluntary.

We guarantee the fulfillment of all your rights under the general Data Protection Regulation, i.e.:

- the right to access the content of your data,
- the right to rectify data,
- the right to request removal of your data,
- the right to limit data processing,
- the right to transfer data,
- the right to object,
- the right to withdraw consent,
- the right not to be subject to automated decision-making, including profiling, as well as the right to object to the processing of your personal data.

We only share your personal data with those cooperating with Wygodnadieta.pl, whose operation is necessary to perform the service in accordance with the contract, in particular they are: entities providing courier / delivery services; entities providing and supporting our ICT systems and providing electronic services, ie those that provide IT services, provide consulting services, audit services or cooperate with us as part of marketing campaigns; entities providing services related to the ongoing operations of WygodnaDieta.pl; entities providing services for payment transactions.

We process your personal data:

-- for the duration of the contract concluded with you, as well as after its completion (but not for more than 10 years from the date of its completion).

- for the purposes of a legitimate interest (eg direct marketing of own services) until you object to such processing,

- we process personal data processed on the basis of your consent until you revoke it. You may withdraw your consent to the processing of your personal data at any time by e-mail to the following address: [odo@wygodnadieta.pl](mailto:odo@wygodnadieta.pl) or in writing: ul. In case of any doubts related to the processing of personal data, you can ask us for information. Notwithstanding the foregoing, you have the right to lodge a complaint with the supervisory body - the President of the Office for Personal Data Protection (address: President of the Office for Personal Data Protection, 2 Stawki Street, 00-193 Warsaw).

## 2. Information from access logs

Based on data from the access logs of our website, we collect information about the use of this website by users. This information is used for technical purposes related to the administration of portal servers as well as for statistical purposes. According to the provisions of art. 15 of the Act of 18 July 2002 on the provision of electronic services (Journal of Laws No. 144, item 1204), we may be required to provide information, including, in particular, the computer's IP number contained in access logs on demand entitled under law state authorities for the purposes of their investigations.

## 3. Links to other websites

We are not responsible for the privacy protection policy applied by website owners to which we have placed links on the WygodnaDieta.pl website. We encourage users to read the privacy statements posted on the websites that collect personal data.

## 4. Use of cookies

By using the Website Wygodnadieta.pl you agree to the use of cookies in accordance with this Privacy Policy. If you do not agree to our use of cookies, you should change your browser settings properly or opt out of using the Wygodnadieta.pl website. Cookies are small files, saved and stored on your computer, tablet or other device while you visit various websites on the Internet. A cookie usually contains the name of the website from which it comes, the "lifespan" of the cookie (that is, its lifetime), and a randomly generated unique number used to identify the browser from which the website is connected. Wygodnadieta.pl uses cookies to collect anonymous, aggregated statistics that allow us to understand how our websites are used and help in improving their functionality and content. By using the Wygodnadieta.pl website, you may receive cookies from third parties cooperating with us, such as Google, Meta. You can find more information about these cookies on the websites of third parties cooperating with us. The default settings of web browsers most often allow the use and placing of cookies in them, both permanent and session. It is possible to configure the web browser in such a way that before each placement of a cookie file you will be prompted. The user can also completely
