WygodnaDieta.pl respects the privacy of every individual using their website.

For this reason we have prepared a document which represents our position on collecting, processing and using our customers personal information.

WygodnaDieta.pl reserves the right to make changes in the Privacy Policy. The current Privacy Policy available on the website http://www.wygodnadieta.pl/polityka_prywatnosci_en.pdf applies to every user of WygodnaDieta.pl

We do not share or sell personal and address data of our customers.

Protection of the confidential personal data of our customers is of the highest importance to us.

1. Personal data

While using WygodnaDieta.pl website, you might be asked to provide certain personal data by, for example, filling in a form. The data that you might be asked for is, in most cases, your name, surname, phone number and email address. Not providing this data will block the activity to which the data was referring. Personal data included in the order form and any other customer data collected is processed in accordance with the customer's authorization and Polish law, especially in accordance with The Act of 29th of August 1997 on the Protection of Personal Data (Legal Journal No. 133, item 883. with later changes) and the Law of 18 July 2002 on electronic services (Legal Journal No. 144, item. 1204). The personal data of customers is treated as a separate database, which ensures adequate protection. A small number of authorized employees of WygodnaDieta.pl have full access to the database for administration purposes. In addition to this, the protection of personal data is enhanced by SSL security technology.

2. The right to inspect, correct and delete personal data

Every customer who fills in an order form or submits their personal data in any other way has full access to this data in order to verify, modify or delete it.

3. Information from Access Logs.

We collect data about customer activity from the access logs on our website. This information is used for technical purposes, connected with server maintenance, and statistical purposes, such as gathering broad demographic information. According to the Law of 18th of July 2002 on electronic services (Legal Journal No 144, item 1204), we may be obliged to release this information, particularly IP addresses contained in access logs, authorized under the law for the needs of investigations by governing bodies.

4. Cookies.

By using Wygodnadieta.pl website you agree to the use of cookies in accordance with this Privacy Policy. If you do not agree to our use of cookies, you should change your web browser settings accordingly, or choose not to use Wygodnadieta.pl website. Cookies are small files that are saved and stored on your computer, tablet or other device while you visit different pages on the Internet. A cookie typically contains the name of the website from which "life" cookies (that is, the time of its existence), and a randomly generated unique number used to identify your browser, which is a merger of the website. Wygodnadieta.pl uses cookies to collect anonymous, aggregated statistics that allow us to understand how our site is used and help to improve their functionality and content. By using the Site you may receive cookies from third parties cooperating with us, such as Google. For more information about these cookies can be found on the websites of third parties cooperating with us. The default settings of most browsers allow you to use them and placing both permanent cookies and session. You can configure your web browser so that the file is placed in front of each cookie appeared appropriate prompt. You can also completely disable support for cookies. This does not limit the functionality of the service Wygodnadieta.pl.
