

REGULATIONS OF THE PROMOTION "TOGETHER EFFECTIVELY, TOGETHER CHEAPER 3"

Promotion period: from the 22nd of June 2015 until further notice.

The promotion applies to special prices of diet sets that will be ordered and paid for during the promotion period, under the condition of ordering a minimum of 3 diet sets to the same delivery address (for at least 3 customers).

1. The promotion period:

WygodnaDieta.pl introduces the promotion "Together is cheaper and more effective!" from the 22nd of June 2015 until further notice.

2. The conditions of the promotion

The promotion "Together is cheaper and more effective" is open to all the persons who:

- a) are eighteen (18) or older as of the date of entry
- b) place the order during the promotion period for at least 15 calendar days
- c) complete the payment process on the second day of the delivery of the order at the latest
- d) order a minimum of 3 diet sets for the same day (for at least 3 customers) to one delivery address (exactly the same address, i.e. identical street name, house number, flat or room number, the same delivery time)

3. Terms of the promotion:

3.1 Price dietary set (including meals for one day for one person) ordered and paid during the promotion period is:

- in the case of an order for 1000 kcal diet - 43,90 PLN,
- in the case of an order for 1,200 kcal diet - 45,90 PLN,
- In the case of an order for 1,500 kcal diet - 47,90 PLN,
- In the case of an order for 1,800 kcal diet - 49,90 PLN,
- In the case of an order for 2000 kcal diet - 50,90 PLN,
- In the case of an order for 2200 kcal diet - 52,90 PLN,
- In the case of an order for 2500 kcal diet - 55,90 PLN,
- In the case of an order for Sport 2200 kcal diet - 52,90 PLN,
- In the case of an order for Sport 2500 kcal diet - 55,90 PLN,
- In the case of an order for Montignac diet 1200 kcal – 50,90 PLN,
- In the case of an order for Montignac diet 1500 kcal – 52,90 PLN,
- In the case of an order for Montignac diet 2000 kcal – 56,90 PLN,
- In the case of an order for Diabetic diet 1200 kcal – 50,90 PLN,
- In the case of an order for Diabetic diet 1500 kcal – 52,90 PLN,
- In the case of an order for Diabetic diet 2000 kcal – 56,90 PLN,
- In the case of an order for gluten-free, lactose-free, gluten and lactose-free 1000 calorie diet - 43,90 PLN,
- In the case of an order for gluten-free, lactose-free, gluten and lactose-free 1500 calorie diet - 47,90 PLN,

- In the case of an order on the Montignac diet, for a diabetic or anti-cellulite - 50,90 PLN.
- In the case of an order for a vegetarian diet is dependent calorie and is: 43.90 PLN (in the case of 1000 kcal diet), or 45.90 PLN (in the case of 1,200 kcal), or 47.90 PLN (in the case of 1500 kcal diet) or 50.90 PLN (in the case of 2000 kcal diet) or 52.90 PLN (in the case of 2200 kcal diet).
- 3.2 The price of a diet set includes the delivery costs, if the delivery address is within free delivery zone (http://www.wygodnadieta.pl/en/bezplatna_dostawa). For any other address, the delivery costs will be calculated individually.
- 3.3 The order may be placed by phone or by filling in an order form at www.wygodnadieta.pl. The order and the conditions will be confirmed by email "order confirmation" sent to the email address given by the customer.
- 3.4 The order can be used from the 22.06.2015 to the end of the promotion.
- 3.5 In the case of any changes in the order, cancellation of some of the sets or changing deadlines, which results in breaking the rule of 3 sets for the same day (for at least 3 customers) being delivered to the same address, the difference in price between the promotion and standard price will be added to the remaining sets.
- 3.6 The minimal order period is 15 calendar days.
- 3.7 The promotion applies only to the sets delivered to the same address in quantities greater or equal 3 sets as described in section 2d of the aforesaid Regulation.
- 3.8 The promotional price for customers mentioned in point 3.8 will apply from the date on which 3 diet sets are delivered to the same address. The difference in price will be refunded in additional days of diet plan added to the current order or through a settlement formed in this way overpaid for the next contract.
- 3.9 The maximum term of the contract is limited by the end date of the promotion, with the exceptions of orders placed and started during the promotion period – the conditions of the promotion will apply to the end of those orders.
- 3.10 Failure to use a purchased order, partially or fully, during the period stipulated in 3.4 and 3.10 through the fault of the customer will result in the loss of this part of the order .
- 3.11 WygodnaDieta.pl will not reimburse customers who through their own fault fail, partially or fully, to use a diet plan.
- 3.12 The customer has a right to change the delivery times and the delivery address, with the condition that WygodnaDieta.pl is informed at least 2 working days prior to the date change.
- 3.13 Changing the delivery times and delivery address in less than 2 working days is not possible.
- 3.14 The current promotion does not apply to orders placed before the promotion period.
- 3.15 This promotion does not combine with other promotions.
- 4. Other regulations:
 - 4.1 WygodnaDieta.pl reserves the right to end the promotion at any time without explanation.
 - 4.2 WygodnaDieta.pl reserves the right to make changes to this regulation at any time without explanation.
